**All Horses & Tack must be delivered by 11:30 a.m.**

1. Our sales are always well-attended by people from all across Canada so please, PRE-BOOK your horses and tack well in advance, we receive literally hundreds of inquiries asking us what is consigned to the sale. The more we know, the better job of marketing we can do on your behalf.
2. Horses are generally sold in the order they are received, with riding horses sold throughout the sale.
3. We will accept all types of horses including minis, donkeys, drafts, broke horses etc.
4. Loose horses are welcome.
5. We will accept new and used tack, saddles, trailers, hay, straw, and other farm related items for our Tack Sales.
6. EID (Equine Information Document)  
Horses consigned to our Regular Horse Sales should have the EID document filled out regarding any drugs which may have been given to the horse in the previous 180 days.  
This is not mandatory; however, it is in the seller's best interest to fill out the document for each horse as the price maybe discounted if this document is not completed.
7. Please download the "EID" forms and "Consignment Sheet" from our website in the "Forms" page.
8. Commission for Tack:  
Sliding Scale (per item)  
First \$5 – 100%  
\$6 - \$250 – 25%  
Over \$250 – 15%  
Bigger ticket items please contact us for a quote
9. Commission for Horses:  
Mature Horses  
Entry Fee \$35  
10% Commission, Minimum \$15/horse  
Miniatures, Weanlings, Yearlings and Two-Year-Olds  
Entry Fee \$20  
10% Commission, Minimum \$10/horse
10. Handling Fee on all Loose Horses will be \$10/horse
11. Jack Auction Group reserves the right to turn away any horse not in good condition or health.
12. Pass-Out Fee \$40, plus Entry Fee  
Consignors who wish to put a Reserve on any Horse must do so in the office and are required to pay the Pass & Entry Fee in full one-hour prior to the start of the horse sale.
13. All Horses are Subject to Provincial Brand Inspection Charges of \$3/head and Hartford Insurance.
14. Settlement to consignors will be made the following Wednesday by mail or e-transfer.
15. Preview of horses and tack will be between 12 Noon and 1:00 p.m.
16. Only horses consigned to the sale are allowed on the grounds.
17. Any buyer or seller caught alley-trading before or after the sale will be fined, minimum triple commission and risks being barred from future sales. If you want the horse, buy it in the sales ring!
